MICRO CAMP (U4-U7)

For players playing 3 vs. 3 or 4 vs. 4 micro soccer in the fall of 2011. This is a great introduction and reinforcement of proper soccer skills. This program has emphasis on FUN and positive encouragement!

JUNIOR (U8-U10)

For players playing 6 vs. 6 or 8 vs. 8 soccer in the fall of 2011. This is an excellent camp for skill development, motivation, and basic tactics. This program offers emphasis on 1 vs. 1 skills training, kicking, and ball control.



Players are divided into small groups with consideration given to age, teammates, playing experience and ability.

- Players must wear athletic clothing and shin guards.
- Make sure to bring a soccer ball and large water bottle.
- Soccer shoes/cleats are strongly recommended
